SITE RULES

In the interests of everyone, we ask you to comply with the following points.

- To be permitted to go onto the Perla di Mare site, settle in, and stay, you must have the authorisation of the manager or his/her representative. You have a duty to be mindful of the tidiness and orderliness of the site and to abide by these Site Rules. Staying at Perla Di Mare implies the acceptance of these Rules and a commitment to comply with them.
- Reception is open every day of the week, from 9:00am to 7:00pm in the high season

- From 11:00pm to 7:00am, customers must not make any noise which could disturb anyone's sleep.
- As regards animals, category 1 dogs are prohibited access.(Art 211.5.1 of Law No. 99-5 of 06.01.1999).
 Small dogs (under 5kg) are allowed but must be vaccinated and micro-chipped. However, out of respect for all customers, we request you to walk your dogs regularly outside Perla Di Mare. Within the site, they ABSOLUTELY must be kept on a lead; this is entirely your responsibility. If any mess is left by your animals, a contribution to the costs of cleaning up will be required. In no event may dogs or other animals be left alone in the mobile homes, mini-villas, and vehicles.
- Within the grounds of Perla Di Mare, vehicles must keep to the speed limit of 10km/hour. Parking must not hold up traffic nor prevent new arrivals from unloading.
 Parking spaces are not numbered. There is no guarantee that you will have a parking slot for your vehicle beside your accommodation.
- Picnicking, playing football, and sitting about on the lawns is forbidden. Planted areas and floral displays are to be treated with respect. Anyone who causes any damage to the greenery, fences, grounds, and facilities at Perla Di Mare will be responsible for it.
- A playground is available for your children. We would ask you not leave them unsupervised by an adult.
- Pitching a tent, or making use of a camping-car or caravan is strictly prohibited.
- As soon as you arrive on site, you are requested to check the inventory which is located in your accommodation as well at the equipment. Please do not hesitate to tell Reception about any item that is missing or defective.
- When you arrive, you will need to pay a deposit of between €300 €400 which will be returned to you on the day of your departure after an inventory check. In the event that you leave early in the morning (before Reception opens), the deposit will be sent to you by post after the accommodation has been inspected. The accommodation must be left in a perfectly clean and tidy state. It is essential that all washing up and storage of crockery, removal of household rubbish and all perishable foodstuffs, and tidying up of blankets are done. It is possible to pay to have the final cleaning done.
 - The deposit will be retained in the event of damage of any kind whatsoever that may have been done to the accommodation in general, the furniture and electrical appliances, curtains, bedding and blankets, cooking utensils, dishes, etc., and if the accommodation has not been left perfectly clean, there will be cleaning costs and costs for the washing and cleaning of any curtains, blankets etc. which have been soiled or stained. The customer undertakes to top up the amount if the costs are greater than the deposit paid.
- We would ask you not to waste water. Washing cars is prohibited.
- A washing machine and clothes drier are available for you in the laundry room. For health and safety reasons, you are requested to follow the instructions when using the equipment.
- No clothes drying facility may be set up outside except on your terrace.
- The garden furniture and the parasol (in the villas only) must not be removed from your terrace.
- From time to time, an order may be issued by the Prefecture banning the use of barbecues. Their use is STRICTLY prohibited when there is a strong wind. In the event of fire, notify Reception immediately.
- Rubbish must be disposed of in the bins provided for this purpose. Beware! Never use the containers beside fire hydrants. They contain firefighting equipment.
- Although site security is in place, users are requested to take all the usual precautions to safeguard their
 property and equipment. The Management refuses to accept any liability in the event of theft of clothing,
 luggage, and miscellaneous items brought onto the site. Report to the Management any suspicious person.
- Access to the spa and jacuzzi is prohibited outside their opening hours. The Management refuses to
 accept any liability in the event of an accident. We reserve the right to exclude those who do not
 comply with these rules, along with their families if these include minors.
- A charge of €60 will be made if door keys are lost, and €100 if safe keys are lost.
